- I. CALL TO ORDER & ATTENDANCE 9:30AM in the Brother Juniper Room.

- II. Opening Prayer Fr. John O'Connor, OFM
- III. 02/16/19 Meeting minutes were approved
- IV. PASTOR'S REPORT

a. Diocesan meeting with Bishop Burbidge

Fr John reported on the recent meeting between the Bishop and priests in the diocese. There was a presentation made followed by a lengthy discussion on the Dallas Charter for the protection of Children, and the current situation in the Church.

The discussion surfaced the following recommendations, 1 that confessionals no longer be enclosed, 2 That priests should not meet with a parishioner unless there are additional staff present in the office area of the parish,3 that priests never meet with a child without a parent or staff member present

b. General

- 1. The Bishop's Lenten Collection stands at 68% of goal.
- 2. Parish finances continue on an upward trend
- 3. A second collection will be held the weekend of 16-17 March to defray the \$6,000 cost for the permanent installation of the additional audio speakers for the Church.
- 4. The organizational consultant will complete an initial report by 22 March.
- 5. The Holy Name Province Ministry Evaluation Criteria is furnished as an attachment. Fr. John noted he will meet with Bishop Burbidge before the HNP meeting with the Bishop. There was discussion of membership on the Diocesan Peace and Justice Commission.

- 6. The HNP evaluation team will visit the weekend of April 13-14. Attendance at a Saturday, April 13th working lunch will be by individual invitation only.
- 7. By Fall 2019 HNP will prioritize all of their ministries. Over the next number of years, the number of HNP ministries is likely to be reduced by 50%. There is a second round of evaluations and prioritizations planned when all 5 of the US Order of Friars Minor merge in 2023.
- 8. School enrollment is up slightly, and Dr. Barber and the school continue press forward for increased enrollment.
- 9. The new parishioner welcome is well received among those attending, however the numbers are low. There was discussion about reaching back to new parishioners to continue contact and promote engagement.
- 10. The Preliminary Holy Name Province Evaluation Report is attached. There are several significant errors relating to area demographics in the report.

V. Strategic Plan

Terry Danner noted that our constitution (Article VIII, Section 1) requires the Pastoral Council to establish a Visioning Committee. The task of the Visioning Committee is to facilitate development and upkeep of the Parish Strategic Plan. An example of the product of a previous Visioning Committee's work can be found in the March 2010 "Assessment of the Adherence of Ministries to the Saint Francis of Assisi Parish's Mission and Vision".
